Procedure: Combine Phase A ingredients and heat to 75-80°C. In a separate vessel, combine Phase B ingredients and heat to 75-80°C. Add Phase B to Phase A with moderate propeller stirring. Cool to 65-70°C and add Phase C ingredients. Fill containers at 65°C.
