Procedure: Combine Phase A ingredients with propeller stirring while heating to 70°C. Cool to 45°C and disperse rice bran wax beads, mixing until uniform.

Stability: One month at 45°C.

Suggested Usage:

- Using fingertip, massage a small amount onto lips using fingertips or by pressing and rubbing lips together to exfoliate.
- Leave on lips for a few minutes as a mask, then using tissue gently wipe away the micro wax beads to reveal smooth, moisturized lips.
- Tip: follow with our Lip Oil or Lip Balm.
