Cool to 45°C and add Phase C. **Stability:** One month at 45°C. **Suggested Usage:** Gently pat the cream around the delicate eye area and let it absorb. Can be applied day or night. **Pro Tip:** Try as a five-minute under-eye mask or mid-day pick-me-up and wipe off remaining residue.
