Procedure: Combine Phase A & B ingredients separately, heating each to 70-75°C. Add B to A and emulsify.

Cool to <45°C and add Phase C.

Stability: 3 months at 45°C. pH 5-6.

Suggested Usage: Apply a few drops to face, neck. Can be used as a booster by combining with Hydrating Gel Cream 100-135A to lock the serum in.
