Procedure: Premix Phase A1 to solubilize oils. Add ingredients in phase A2 one by one with slow mixing to avoid aeration. Adjust pH if needed to 5.5. Fill into foaming bottles.

Stability: 1 month at 45°C.

Application Instructions: Gently massage onto wet skin, lather, and rinse.
