Can be used alone or augmented with a few drops of our Booster Serums to target specific skin concerns:

- **Well-aging Booster Serum** – regenerate, restore, improve skin texture, reduce wrinkles and roughness
- **Brightening Booster Serum** – brighten, lighten, cool
- **Moisturizing Booster Serum** – anti-aging, regenerate, reduce inflammation, extended moisture

Procedure: Prepare phase A and Phase B separately. Add B to A with high speed stirring. Add C and homogenize until emulsified.

Stability: 5 months at 45°C.
